Same property as 64-81, with an allotment of waste land on the Old Heath, allotted by Enclosure Act to Mary Barns. To the use of John Forster Pettekin Osborne and Arthur Thomas Osborne.

83. 1874 Memorandum of conditional surrender by John Foster Pettikin Osborne and Arthur Thomas Osborne, both of Colchester, brewers and porter merchants. Same property as 82. To the use of Frederick Blomfield Philbrick of Colchester, gent., and Walter Payne Gepp of Chelmsford, Essex, gent.

110. 1789 Memorandum of surrender by William Cook of Hoxne, Suffolk, miller, and Mary, his wife, daughter of the late John Bennett.  
Messuage called Borehams and close of land called Homefields, about four acres.

Parties: Jacob Verlander of Colchester, farmer, Mary Poyner of Colchester,

spinster, Benjamin Gibson of Halstead, Essex, surgeon, and James Mansfield of Colchester, baymaker, executors of Mary Poyner's will, Benjamin Strutt of Colchester, gent., and William Francis of Colchester, gent.

117-118. 1810-1825 Memorandum of conditional surrender and warrant of satisfaction re same property as 111-112.  
Parties: Jacob Verlander of Colchester, farmer, and Rev. James Bass of Halsted, Essex, minister.

119-121. 1811-1825 Memoranda of surrender and conditional surrender, and warrant of satisfaction, re customary lands called Carters.  
Parties: James Walford, miller, Jacob Verlander, farmer, Elizabeth Eglonton Thorn, widow, James Thorn, merchant, Henry Thorn, silversmith, and William Francis, gent., all of Colchester.

122-123. 1814-1817 Memorandum of conditional surrender and warrant of satisfaction re two messuages called Northerns alias Northens, close called Peacocks Garden (excluding piece of land called Broomfield, piece of land called the Folley, piece of land called Rootseys Marsh and piece of land formerly called Symonds pasture, later called Seaman's Garden, all of which were formerly part of Peacocks Garden and then were enfranchised by the lord of the manor and sold by Jacob Verlander to Samuel Bawtree and George Savill, both of Colchester, distillers) three fields called Upper Broomfield, Saint Giles's Field and the Lower Broomfield, messuage called Borehams, and close called Homefield, all in the parishes of St. Giles and St. Botolph.  
Parties: Mark Beauchamp Peacock of Chelmsford, Essex, gent., Jacob Verlander of Colchester, farmer, and Judith, his wife.

124. 1818 Memorandum of grant of licence by Samuel Blomfield, gent., lord of the manor, surviving bargainer and assignee of the real and personal estate of Henry Thorn, a bankrupt, to Jacob Verlander.

To demise same property as 113-120, and a piece of land late part of the Old Hythe Marsh, bounded on the north-west by Cut Marsh, and on the north-east by the River Colne, and a piece of land, part of the marshes and wastes of the manor, containing eight acres, abutting north-west on the channel of the River Colne.

125-127. 1823-1825 Memorandum of conditional surrender and warrants of satisfaction re piece of land, part of the Old Hythe Marsh, bounded on the north-west by the Cut Marsh, and on the north-east by the River Colne.

Parties: Jacob Verlander of Colchester, farmer, later of Granchester, Cambs., gent., Elizabeth, his wife, Rev. Thomas Stollery of Charlotte Street, Fitzroy Square, Middx., dissenting minister, executor of the will of Mrs. Sarah Gibson of Tottenham Court Road, Middx., widow, and John Gibson of Chelmsford, Essex, surgeon.

128-131. 1825-1826 Memoranda of Jacob Verlander's surrenders of all his aforementioned lands to Edward Wakefield of Pall Mall, Middx., esq., and letter of attorney to Edward Daniels of Colchester, gent.

Risbee's cottage

132. 1819 Memorandum of surrender by Samuel Bawtree of Colchester, esq., of all his copyhold lands and tenements to the uses of his will.

133-134. 1849-1850 Memoranda of admission of Samuel Bawtree, late of Colchester, now of Port Philip, South Australia, esq., to Risbee's Cottage in the parish of St. Giles after the death of his mother, and his surrender of it to George Gilbert of Colchester, land surveyor.

139-142. 1821-1849 Memoranda of surrenders and copy of the will (1822) of Joseph Downes, re piece of land, late part of the heaths, commons and waste lands of the manor, situate in St. Giles parish, Colchester, abutting north-east upon the road from the Bell Inn to Battleswick, and south-west upon Roundabout Field, and a piece of land with a messuage with outhouses and buildings.

Parties: Joseph Downes of Colchester, yeoman, Dinah, his wife, Naphthali Goose of Colchester, chemist and druggist, Sarah Goose of Ipswich, Suffolk, widow, and Edward Gridley of Wivenhoe, Essex, shipwright.

143-147. 1831-1858 Memoranda of surrenders and warrant of satisfaction re piece of demiseable land, about one rood, with five messuages, situate on the Second Old Heath in the parish of St. Giles, Colchester, abutting towards the south west on the public road from Colchester to East Donyland.

Parties: James Purkiss of Colchester, farmer, Emanuel Gregory of Colchester, later of Kings Hill, Wednesbury, Staffs., engineer, Sarah, his wife, James Brown of Elmstead Market, Essex, innkeeper, Horatio Oakes of Woolwich, Kent, engineer, and Edward Williams of Colchester, doctor of physic.

148-150. 1843-1857 Memorandum of conditional surrender, draft admittance and abstract of title re messuage and the piece of ground upon part of which the messuage stands, formerly part of the

waste of the manor situate at Old Bell Heath in the parish of St. Giles, between the road leading to Rowhedge and the road leading to Battleshall, a messuage divided into two tenements and the piece of ground on which the messuage stands, formerly part of the waste land on Old Bell Heath, abutting on the road to Battleshall and on a field belonging to Edward Austin, to all of which property James Purkiss was admitted in 1833 on the death of James Osborn Purkiss.
