Cranage (Cheshire)

1. c.1270-1271 Gift, of all the donor's land in 'Cranlach' [regte Cranage] called stanilandes; cultivated as well

as uncultivated, with his growing wood (except for four pieces lying near the vill of Cranage); also of a piece lying in 'Serlecroft' with two houses built there; and also all the donor's right in the mine [or quarry] of 'Ruddeheth', within the boundaries of Cranage.

Parties: (i) Robert de Croxton.

(ii) To God and the church of St Werburgh of Chester and the donor's chief lords S[imon] the abbot and the convent of the same place.

Witnesses: The lord 'Reg' [alias Reynold] de Grey, then justice of Chester, Richard de Wilburham, sheriff of Chester, Robert de Huxley, Richard de 'Orreby', John de 'Wetenham', Richard Bonetable, Richard de Cranage, Henry of the same place, Thomas de 'Gorstr', Roger de 'Bemilsham', 'and others'.

2. [c.1272-1274] Grant, of all the service which Richard, son of the donor, owes him, for all the land the donor gave him in 'Craunach' [recte Cranage], together with a house and all right which the donor had in the same.

(ii) To God and the church of St Werburgh of Chester and the donor's chief lords Simon the abbot and the convent of the same place.

3. [c.1277]

Quitclain, of all the land in 'Craulache' [recte Cranage] called 'stanilandes', which Robert de Croxton, the donor's father, gave to the donees, besides the moiety of the mine [or quarry] of 'Ruddehet' belonging to the vill of Cranage.

Parties: (i) Richard, son of Robert de Croxton.

(ii) To God and the church of St Werburgh of Chester and the donor's chief lords Simon the abbot and the convent of the same place.

4. [13th cent.]

Grant, of the homage and all the service which the grantor's brother, Robert de 'Crocston' [recte Croxton] did or owed the grantor for two tenements with appurtenances held of the grantor in the vill of 'Croulache' [recte Cranage].

Quitclaim, of all the rent taken annually by the donor from the vill of 'Leg' [recte Lees, Cheshire], that is, 5/-; and gift, of all the demesne of the donor in Cranage-cum-Hermitage, Lees, 'Crokedelache' and 'Windhgates', with all appurtenances, in homages, services, rents, reliefs, wards, escheats, etc., for which gift the donees have given the donor ll silver marks.

6. [? Between 1233 and 1244]

Gift, of all the donor's land in 'Leghes' [recte Lees], in demesne tenure, villein service and homage, and all customs, with a wood and a

meadow and all appurtenances, and all escheats and commodities; and all the land called 'DerneLeHegreue', with appurtenances.

Parties: (i) Robert, son of Lidulph the sheriff, and Mabel his wife.

(ii) To God and the Blessed Mary and the house of St Werburgh of Chester, and the abbot and convent serving God in the same place.

7. [c.1247-1248] Quitclaim, of all right and claim of the grantor in the vill of 'Leg' [recte Lees], with all appurtenances.

(ii) Roger, abbot of St Werburgh of Chester and the monks of the same place.

8. 1267

Gift, of all the land the donor formerly held of the donees in the vill of 'Leghes' [recte Lees], with appurtenances, for which gift the donees have given the donor and his heirs, and confirmed by charter, a bovate of land with appurtenances in the vill of 'Gorstre'.

1. 16 Nov. 1301

Bond, in 100/- sterling, by Dunstan de 'Trathell' and Thomas le White, to the prior of the church of Christ, Canterbury, and the convent of the same place, and their successors, against the invalidation by an award in court of the remise and quitclaim by the former to the latter of all right and claim which their wives might have in a tenement called 'Scottestounne', in 'Eirchelton' [recte Birchington], in the Isle of Thanet.

2. !In curia de farleghe', 1235

Confirmation, of the gift which Hamon, the donor's father, made to the donees, of a free rent of $3/\frac{1}{2}d$ from a tenement in 'farleghe' [recte Farleigh].

(ii) The prior and convent of the church of Christ, Canterbury.

Grant, of a free rent of $7/83^{d}$ from a tenement in Farleigh, viz: from Sylvester the clerk, 18d for his messuage and 12d for a meadow called 'Tredegoldesmed'; from the heirs of Dyonisius de La Snad, $2/22^{d}$, for 4 acres of land in Snad; from Goddard de 'Pyrifeld' 19d, for land called 'bergheker'; from Walter of the chapel, 12d, which Hamon de 'Pyrifeld' used to pay the grantor for land called 'Crullesland'; and from Paul de 'denestrate' and Adam, son of James, 5d and 9 farthings, for land which was Ralph Rut's.

Gift, of all the part of the land which the donor has in a piece of land called 'pendakere', with all appurtenances, in the vill of Godmersham, for an annual rent of 3d for all secular services and temporal demands, for which sale [sic], gift, etc., the donees have paid the donor 15/- for a fine.

5. [13th cent.]

Gift, of $2\frac{1}{2}$ acres of land in Greenway, that is an acre on 'Hoguihill' and $1\frac{1}{2}$ acres of Hawisa, the donor's mother, for an annual payment of 6d, payable at the Nativity of the Blessed Mary, in Hollingbourne cemetery, for all services, but the donee to defend the land for half an acre of the land of 'Warland' against the court of Hollingbourne.

7. [13th cent.]

Gift, of 6 acres of land in Hollingbourne, to be held of the donor by hereditary right for an annual payment of 4d for rent, customary services and all demands in respect of the court of Hollingbourne, for which gift the donee paid 27/7d for a fine, the donor confirming the gift in the court of Hollingbourne, with the agreement of the lord of 'Helia', then proctor of Hollingbourne.

Parties: (i) Eilnoht [alias Eylnothi], son of Godrune.

(ii) Roger de 'Modintune'.

Gift, of all the land with appurtenances [in Hollingbourne] which Roger de Modintune held of Hawisia, the donor's mother, according to the charter of the same, the donee to hold the same land similarly.

(ii) Margaret, daughter of Adam de Greenway, and his heirs.

(ii) The prior and convent of the church of Christ, Canterbury.

Surrender, of 12 acres of land and a messuage with appurtenances in 'Modinta' [in Hollingbourne], which Roger de 'Modinta' held, for ever.

11. 1228

Gift, of 6 acres of land with appurtenances in 'Northblen' [? recte North Blean], in length between the land of the prior and convent of Christ Church, Canterbury, and the land of 'Deringus', and in width between the land which was Robert the knight's, and the land which was Richard the chaplain's, for an annual rent of 4d, for which deed the donees have given the donor 5 silver marks for a fine.

Parties: (i) Simon de 'Blen' [? recte Blean].

(ii) The prior and convent of the church of Christ, Canterbury.

12. 'in curia de blean'. 1234

Gift, of l acre of land with appurtenances in 'Northblean' [recte North Blean], for an annual payment of ld for all services, customary suits and all other temporal demands, for which gift the donees paid the donor by the hand of John de 'Crumdale', then cellarer to the donees, 14/-, in the court of Blean.

(ii) The prior and convent of the church of Christ, Canterbury.

Confirmation, of a gift which the donor's father, Solomon, made them, of 2 acres of land with a ditch and other appurtenances, in the field called 'northblen' [recte North Blean], for 2d a year for all customary services and temporal demands, for which confirmation in the court of the lord Hamon del Blen, with the consent of Simon del Blen, the donees have given 1 mark.

14. 'Aghene'. 23 Nov. 1330 Gift, of $2\frac{1}{2}$ acres and one rood of land with appurtenances, in the parish of 'Olderomene' [recte Old Romney], at 'Aghene', to hold the same of the chief lords of the fee by the service thence annually owed to them.

Parties: (i) Robert, son of Robert Willem 'de marisco de Romene' [recte Romney Marsh].

(ii) Bertram de Twitham.

Gift, of $2\frac{1}{2}$ acres and one rood of land with appurtenances in the parish of St Clement, 'de veteris Romen' [recte Old Romney], in the tenure of the prior and convent of the church of Christ, Canterbury, to hold of the chief lords of the fee by the services thence owed and accustomed by right.

16. 3 Nov. 1342

Gift, of $2\frac{1}{2}$ acres and one rood of land with appurtenances in the parish of St Clement, 'de veteris Romenal' [recte Old Romney], in the tenure of the prior and convent of the church of Christ, Canterbury, to hold of the chief lords of the fee by the services thence owed and accustomed by right.

Parties: (i) William de 'Tryndle'.

(ii) Alexander Hanekyn de Canterbury.

17. [13th cent.]

Gift, of two crofts called 'Sandpet' and 'Hamstal', in the vill of Peckham, for an annual payment of 6d for all services, customary suit of court and other exactions, for which the donees have paid 60/- for a fine.

(ii) Henry de Ospringe, clerk, son of Simon.

'Prestbregg(e)'

18. Christmas, 1294

Agreement, between the prior [Henry de Eastry] and convent of Christ Church, Canterbury, on the one part, and Nicholas de 'Lafham' [recte Lavenham, Suffolk], on the other, whereby the former give the latter a piece of meadow next to their mill of 'Prestebregg', and undertake not to raise or draw off the water in the pond of their mill of 'Hadleghe' [recte Hadleigh, Suffolk], to the latter's detriment; the latter giving the former a piece of meadow next to the mill at Hadleigh, together with the trees and other appurtenances; and also, for the sake of peace, all the growing trees with the ground on the bank near the mill pond of 'Prestebregge', concerning which at some time a plea was moved between them in the king's court by writ of novel disseisin, it being allowed the officers of the prior and convent to clean out the mill pond at 'Prestebregge'.

19. Aug. 1257

Grant, in free, pure and perpetual alms, for the use of the poor in their almshouse in Canterbury, of an annual rent of $6\frac{1}{2}d$, and 3 hens at the Nativity, from a free rent in 'sesaltre' [recte Seasalter], which Thomas and Adam, sons of Wybarnus the pilgrim were accustomed to pay the grantors, and the rights the grantors have in the land.

Parties: (i) Jordan Swetman and Joan [or Jane], daughter of Matthew of 'Hwitstapele' [recte Whitstable].

(ii) The prior and convent of the church of Christ, Canterbury.

Witnesses: John de 'wadenhale', Nicholas de 'Elmdemne', Andrew, son of Manasser, William, son of Constance, John, son of 'Whrici', John, son of Elembertus, James 'de fonte', John, son of Godfrey, James his brother, Alexander the parson, Luke of the Marsh, Henry 'plūpe', 'and others'.

20. 5 June, 1301

Lease, in perpetuity, of the manor of 'sesaltre' [recte Seasalter], with appurtenances and 100 sheep valued at 1/2d each, for an annual payment of 10 marks in equal portions, viz: 33/4d at the quindene of the feast of the Nativity of St John the Baptist, at the quindene of Michaelmas, at the quindene of the Nativity of the Lord, and at the quindene of Easter, for all services belonging to the lessors, saving to them all royal fish, wreck and escheats of the sea, and also all royal rights appertaining to the manor,

the lessors to enter and take possession in the event of arrears of payment, the lessee to return the value of the 100 sheep within a month of the lessors' entering if the sheep are no longer there, the lessee being forbidden to alienate or otherwise dispose of the manor to other than a rightful heir, without the permission of the lessors.

21. [? Between 1222 and 1238]

Robertsbridge Abbey

Exemplification of exchequer proceedings, 10 July 1356

The case concerns the discharge of the abbot of Robertsbridge from sums charged in respect of the ninth of sheaves, fleeces and lambs on the abbey's estates in Kent and Sussex granted by the Parliament held at Westminster in Lent 1340.

On 12 Oct 1342 a writ was sent to the treasurer and barons of the exchequer ordering distraints made on the abbot to be released; by an agreement made at the parliament, only the estates acquired by religious houses since the levying of a tenth on spiritualities in 1291-92 were to be taxed.

The abbot appeared by his attorney Bartholomew de Fourneux on 24 Apr 1346 in answer to an exchequer summons. It appeared by the Pipe Roll of 1344 that £1 16s 10d had been charged for the ninth in Kent, and £13 2s 10d in Sussex (£1 6s in Waldron, 17s in Beckley, 13s 4d in Salehurst, £3 7s 8d in Ewhurst, 3s 4d in Brightling, 7s in Sedlescombe, 14s in Chiddingly and £5 14s 6d in Sutton in Seaford).

From an examination of the rolls of taxation of the temporalities of the clergy in 1291-92 it appeared that the manor of Lamberhurst in the diocese of Rochester was valued at £16, property in Broomhill, Warehorne, Snargate, Sandhurst, Rolvenden and Benenden in the diocese of Canterbury at £12 10s 10d and unspecified property in the diocese of Chichester at £80 13s 4d.

The abbot pleaded that he should be exonerated from the whole payment since no land had been acquired by his house since the taxation of 1291-92.

After unsuccessful attempts to summon juries of Kent and Sussex, William de Peek, the [treasurer's] remembrancer, [see Officers of the Exchequer (L & I Soc special series 18) p53] was ordered to hold inquests in Kent and Sussex.

On 26 June 1346 Peek returned copies of inquests which he had held at Newenden (for Kent) and at Knell [in Beckley] (for Sussex) on 9 June 1346.

Walter de Sonyngleye, Thomas Coppyng and other Kent jurors (not named) stated that the abbey had not acquired any land in Kent since 1291-92.

Robert de Hore, Robert de Bromham and other Sussex jurors (not named) stated that the following had been acquired by the abbey in Sussex since 1291-92:

a messuage, carucate of land and 4s 5½d rent in Waldron, worth £1 6s 9½d, acquired from Roger Laket of [East] Blatchington in 1335 [Possingworth in Waldron - for Roger's charter, see Calendar of deeds...at Penshurst, 345].

The king inspects and confirms letters patent of 1 Nov 1343, which pardoned the appropriation, without licence, by the abbot and convent of Robertsbridge, of the advowsons of Salehurst and Udimore, of the church or chapel of Mountfield, of the prebend of Salehurst in the royal free chapel of Hastings and of the two carucates of land (of which the prebend consists), which had been alleged on the king's behalf in an action of quare impedit in common pleas to be held in chief.

The patent of 1343 recites the grant by Edward II of a licence to William de Etchingham to alienate the advowsons, worth 50 marks a year, to Robertsbridge, in part compensation for £100 worth of their land of their own and other fees which had been lost to the sea. Although no mention was made in the licence of the prebend, a subsequent patent confirmed its appropriation to the abbey, and ordered the dean to admit the abbot and his successors as canons. The patent is said to be granted in consideration of the circumstances, a fine previously paid by the abbey for a former patent and of the abbey's likely ruin by the litigation on the quare impedit.
